VLCT Board President Mary Ann Goulette called the joint meeting to order at 1:04 p.m. and asked for a motion to approve the minutes.

Upon motion (Frank/Hogan), duly adopted, the group voted unanimously to approve the May 21, 2026 meeting minutes as presented.

President Goulette asked for a motion to enter into Executive Session.

PACIF Board President Aaron Frank moved that the group find that premature general public knowledge of contract negotiations between PACIF, VERB and VLCT regarding the Administrative Services Agreement would clearly place PACIF and VERB at a substantial disadvantage and further moved that the working group of VLCT, PACIF and VERB board members go into executive session to discuss contractual negotiations between VLCT, PACIF and VERB and to invite Ted Brady, Phil Latvis, Phil Woodward, Lynn McNamara, Gary Kupferer and Russell Young to join the executive session. **The motions were seconded by Jessie Baker, all approved and the working group entered into executive session (1:06 p.m.).**

Kelley Avery left the meeting and VERB and PACIF Board members, Phil Woodward and Russell Young left to meet separately during a short caucus of the VLCT Board and staff.

Trust board members, Russell Young and Phil Woodward rejoined the VLCT board and staff at 1:18 p.m.

The Zoom meeting was interrupted briefly at roughly 1:25 p.m. due to a technical issue.

The Trust board group and VLCT groups separated again at roughly at 2:05 p.m., then combined once again at 2:20 p.m.

Upon motion (Frank/Odit), duly adopted, the group voted unanimously to leave executive session and return to open meeting (2:47 p.m.).

Upon motion (Frank/Hogan), duly adopted, the group voted unanimously to adjourn meeting (2:47 p.m.).
